

CO-PERFORMER PARTICIPATION AND RIGHTS AGREEMENT

("Agreement")

This Agreement is made in favor of [UPLOADER'S FULL LEGAL NAME], hereinafter referred to as the "Producer."

In exchange for valuable consideration, the adequacy and receipt of which are hereby acknowledged, I, [CO-PERFORMER'S FULL LEGAL NAME], residing at _____, agree to the following terms:

1. Voluntary Execution

I declare that I am signing this Agreement knowingly and willingly. I am not under any form of duress, coercion, or undue influence. I possess the legal capacity and mental competence necessary to enter into binding contractual obligations.

2. Authorization to Record and Appear

I consent to being photographed, filmed, audio-recorded, and otherwise captured in visual or audiovisual form by or on behalf of the Producer.

I must select one of the following options:

(A) Single Production Authorization

This consent applies exclusively to the following production:

(B) Continuing Production Authorization

This consent applies to the production described below and may also extend to additional similar recordings created with the Producer from time to time after the execution of this Agreement Description: _____

All participation is voluntary and undertaken without force, threats, or improper inducement.

3. Age Verification and Legal Status

I represent and warrant that:

- I am at least eighteen (18) years of age, or older if the age of majority in my jurisdiction exceeds 18;
- I have reached the legal age of majority and legal consent in the jurisdiction where I reside;
- I possess full legal authority to participate in adult-oriented material;
- I understand the explicit nature of the content to be produced;
- I consent to appearing partially or fully nude and/or engaging in adult activities as part of the production.

4. Identification Documentation

I agree to provide the Producer with:

1. A valid government-issued photo identification document displaying my legal name, photograph, date of birth, and expiration date. The document must not expire within six (6) months of signing; and
2. A government-issued document confirming my legal name and residential address.

These documents (collectively, the "Verification Materials") shall be attached to this Agreement.

I authorize the Producer to provide copies of the Verification Materials to any hosting platform, distributor, compliance service, regulatory authority, or governmental body as required by law or platform policy.

I affirm that all documents submitted are authentic, lawfully obtained, and unaltered.

5. Grant of Rights

I irrevocably grant to the Producer the perpetual, worldwide, transferable, sublicensable right to:

- Use, reproduce, distribute, transmit, display, and publicly perform the recordings;

- Edit, modify, adapt, crop, combine, or create derivative works;
- Market, advertise, sell, rent, license, or otherwise commercially exploit the recordings;
- Use my image, likeness, voice, stage name, and biographical information in connection with the content.

This grant of rights is unlimited in duration and territory and applies across all media formats now existing or later developed.

The Producer may distribute the content through any website, subscription platform, digital marketplace, streaming service, or related subdomain (collectively, the “Platform”).

6. Online Publication and Searchability

I acknowledge and understand that:

- The content may be made publicly available online;
- The content may be searchable through the Platform and affiliated networks;
- Search engines may index, cache, archive, or display references to the content.

I understand that removal from search engines or third-party sites is not guaranteed and may not be within the Producer’s control.

7. Unauthorized Distribution by Third Parties

If the content appears on websites not authorized by the Producer or its licensees, I may pursue removal or destruction of such copies at my own expense. The Producer is not responsible for unauthorized third-party distribution.

8. Ownership of Content

I acknowledge that all rights, title, and interest in the content, including original recordings, copies, digital files, edits, masters, and derivative works, are the exclusive property of the Producer.

I retain no ownership interest in the content.

9. Responsibility for Participation

I accept full responsibility for my decision to participate. I agree that:

- No minors will be involved;
- The production will not involve illegal conduct;
- I will not infringe upon any third party's intellectual property rights;
- I will not violate any person's privacy or publicity rights.

I assume all risks associated with my participation.

10. Release and Indemnification

I hereby release and forever discharge the Producer and any Platform from any and all claims, demands, liabilities, damages, losses, or causes of action arising from or related to:

- My participation in the content;
- The creation, distribution, or commercial exploitation of the content;
- Any reputational, financial, or personal consequences resulting from publication.

I agree to indemnify and hold harmless the Producer and the Platform against any claims arising from my breach of this Agreement or misrepresentation.

11. Binding Effect

This Agreement shall be binding upon me and my heirs, executors, administrators, legal representatives, and assigns. It shall benefit the Producer and its successors, licensees, assigns, and affiliated entities.

12. Opportunity for Independent Counsel

I confirm that I have read this Agreement in its entirety and understand its terms. I acknowledge that I have had the opportunity to consult independent legal counsel prior to signing. This Agreement shall not be construed against either party as drafter.

13. Severability

If any provision of this Agreement is determined to be invalid or unenforceable, the remaining provisions shall remain in full force and effect to the maximum extent permitted by law.

14. Compliance With Applicable Laws

I agree that I am solely responsible for complying with all laws and regulations applicable to my participation in adult-oriented content in my jurisdiction.

15. Execution and Counterparts

This Agreement may be executed electronically, by scanned signature, facsimile, or in multiple counterparts. Each executed copy shall be deemed an original, and all copies together shall constitute one binding instrument.

16. Governing Law and Jurisdiction

This Agreement shall be governed by the laws of _____.
